## REPORT ON LIMITED REVIEW

Review Report to
The Board of Directors of

- 1. We have reviewed the accompanying statement of unaudited financial results of Bhiwani Vanaspati Limited ("the Company") for the quarter ended on 30<sup>th</sup> September, 2018 and year to date results for the period ended 30<sup>th</sup> September 2018 ("the statement"). This statement has been prepared by the Company pursuant to Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the SEBI Regulations"), read with SEBI circular no. CIR/CFD/FAC/62/2016 dated July 5, 2016.
- 2. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
